I. Meeting Opening (7:00 pm)

- Stephen Reed (Chair) calls meeting to order at 7:02 p.m.
- Flag Salute
- Friendly Amendment to Agenda

- Election of Jeanne Legault to 37th LD Treasurer
 - Voice vote is unanimous in favor of Jeanne Legault
- Recommendation from chair to pay \$100/month to the person filing the 37th District Democrats' PDC forms and other forms
 - o Voice vote is unanimous in favor of proposal

 - A voice vote is taken and passed to endorse all candidates as a block

III. King County

- Proposition 1: King County Parks Levy (which will be on August Primary)
 - Voice vote to support the levy passes
- King County Assessor
 - John Arthur Wilson is nominated
 - o A voice vote is taken and passed to endorse John Arthur Wilson
- King County Director of Elections
 - No motions to endorse
 - Movement to table this endorsement until the General Election
 - Voice vote to table the endorsement passes
- King County Council Position Number 2
 - Nominations for Larry Gossett and Girmay Zahilay
 - Larry speaks for one minute (then: speaker in favor; speaker against; speaker in favor)
 - Girmay speaks for one minute (then: speaker in favor)
 - Speaker in favor of Larry; speaker in favor of Girmay; speaker against Girmay

- A ballot vote is taken and Girmay Zahilay is endorsed by 108 to 45 with 1 spoiled
- King County Council Position Number 8
 - Nomination for Joe McDermott
 - Joe McDermott speaks for one minute
 - A voice vote is taken and Joe McDermott is endorsed

IV. Port of Seattle

- Position Two
 - Preeti Shridhar and Sam Cho and Ali are nominated for endorsement
 - Preeti speaks for one minute; Sam Cho speaks for one minute; Speaker in favor of Sam Cho speaks; Ali Scego speaks for one minute
 - A ballot vote was taken: Preeti = 29 votes; Sam = 53 votes; Ali = 43 votes; No Vote/Spoiled = 3 votes. This is inconclusive and will lead to a second round
 - Speaker in favor of Preeti; speaker in favor of Sam; speaker in favor of noendorsement (but this does not progress)
 - A Round Two ballot vote is taken: Preeti = 30; Sam = 53; Ali = 45; No Endorsement = 6 votes. Preeti will be dropped and a third round of voting will occur
 - A Round Three ballot vote is taken: Sam = 57; Ali = 44; No Endorsement = 13.
 This is inconclusive and a fourth round of voting will follow
 - Motion for Dual Endorsement. Seconded. A voice vote is taken and Dual Endorsement is passed. Both Sam and Ali are endorsed
- Position Five
 - Fred Felleman is nominated
 - Fred speaks for one minute
 - o A voice vote is taken and Fred Felleman is endorsed

V. City of Renton
